- Limitation of Liability: Service plans exclude any liability for special, indirect or consequential damages. Liability and Purchaser's sole remedy for performance or non-performance under these plans is limited to the cost of the plan.
- This contract does not cover residential units over 250,000 btu/hr of heat input, plumbing and piping such as low water cutoff, water feed valves, expansion tanks, autovents, manual valves, zone valves (heads or bodies) bleeding of radiators, removal of air in system beyond typical, pH treatment system, condensate drain suitability, water quality or other related plumbing system.
- The term of the Plan is one year. At the end of each year, unless advised, we will invoice for a renewal term at the current rate.
- The covered unit is the heater and or air conditioner on which maintenance is performed under this agreement. If there are multiple heaters or air conditioners, you will be required to specify which unit(s) the coverage is to apply.
- The covered unit does not include related equipment such as humidifiers, zone valves, electronic air cleaners, distribution ducts, piping, fuel line, oil tanks, or the electrical service.
- The 10% discount will be applied to our current billing rates for labor to perform any repairs to the covered unit. The discount does not apply to the purchase of replacement equipment.
- We may refuse service if conditions present a risk or harm to our personnel.
- Customer understands and acknowledges that Tucci's obligation to provide the goods and services called for in this plan specifically and expressly subject to any cause or causes beyond its control, including, but not limited to, acts of God, acts of civil or military authority, war, riots, civil disturbances, terrorist acts, labor disputes, strikes or picketing regardless of targeted employer, accidents, explosion, fire, storm, flood, earthquake, delay in receipt of materials, tariffs or order of any governmental agency.
- Company's decision not to provide the goods and services as a result of, or which is related to, any of the foregoing reasons shall not be considered a breach of this agreement.
- The cost of this plan is not refundable, but the coverage may be transferred to a new owner/occupant.
